An ABC Assistant Barefoot Judge is eligible to serve as an event judge at USA Water Ski/ABC-sanctioned local and regional tournaments; a timer, meter reader, masterboard or jump +assistant at any USA Water Ski/ABC-sanctioned tournament; and an examiner for ABC First Class barefoot ratings.

Qualifications: You must be a current "Active" USA Water Ski member to become an ABC Assistant Judge. All ABC judges must obtain and be familiar with the IWSF Rules and ABC Addendum. Rulebooks and addendums are available upon request from USA Water Ski Headquarters.

Renewal: ABC Assistant Judges may renew their rating by judging four (4) USA Water Ski/ABC-sanctioned slalom and trick tournaments and two (2) jump tournaments every two years. Renewal takes place at the end of the odd year (at the end of 2003 for work performed from January 1, 2002 through December 31, 2003). Failure to work the required tournaments will result in loss of the rating.

Instructions: The following blanks must be completed and signed by the Chief Judge of the tournament in which the experience was completed for all three events (slalom, tricks and jumping). All of the work must be performed during USA Water Ski/ABC-sanctioned tournaments. Signatures on outdated applications will be accepted for requirements on the current form if the old form is attached to this application. Upon completion, mail the application to USA Water Ski Headquarters, Attention Competition Department, 1251 Holy Cow Road, Polk City, FL 33868-8200 for processing. You should retain a copy of this application for your records.

Please Note: Skiers who hold an ABC Open rating in slalom, tricks and jumping may be issued an ABC Assistant Judge rating by sending this application, with the top portion completed, or a written request **and** a copy of the signed rating card to USA Water Ski's Competition Department.

Attention Chief Judges: Please be discriminating. The ABC cannot maintain a high standard of judges' qualifications unless you assume the responsibility of refusing to approve any but exceptionally qualified applicants.
